

ST. LOUIS RAMS CLUB TRANSFER FORM INSTRUCTIONS



Rams Club Seat Memberships are fully transferable provided the account is in good standing. Transfers will be processed **from February 1 to May 15**, and from **September 1 to October 31**. All transfers are subject to the terms listed below. These terms are also detailed in the St. Louis Rams Club Membership Agreement.

Transfer Terms

- **For one year (365 days) following the purchase of the Club Seat Membership, the Club Seat holder cannot transfer the ownership of the Club Seat Membership except upon the occurrence of a Special Event. A Special Event is as follows:**
 - The occurrence of a circumstance beyond the control of the Club Seat holder, such as death, disability, employment relocation, or similar event.
 - The transfer to an Immediate Family Member or Related Party. An Immediate Family Member is considered any grandparent, parent, spouse, child, stepchild, sibling, grandchild and great-grandchild of an individual Club Seat holder. A Related Party is considered any person or entity that owns or controls, or is owned or controlled by, the Club Seat holder.
 - The transfer in conjunction with a major business transaction in which the acquisition of the Club Seat Membership is not the intent of the transaction.
- **All transfers, whether pursuant to a Special Event or after the first year of ownership, will be subject to a transfer fee.** A completed transfer form is considered one transaction. The transfer fee is calculated by the number of transfer forms submitted, not the number of seats being transferred. The transfer fee is \$100.00 per transaction.
- In the event the current Club Seat holder has a balance due on the account (Club Membership Pro-Rate) for the seats being transferred, the balance must be paid in full at the time of the transfer for the transfer to be executed.
- The transfer of a Club Seat Membership by the current Club Seat holder will not be recognized by the Rams until the transfer is properly recorded in the Ram's records, which includes receipt of the signed Club Membership Agreement from the new Club Seat holder.
- The Rams reserve the right to deny any transfer to any person, company or organization.
- By executing the transfer form, the new Club Seat holder agrees to accept and be bound by all terms and conditions of the Rams Club Membership Agreement.

Completing the St. Louis Rams Club Seat Transfer Form

Part I To be completed by the current Club Seat holder

- If the account is in a business name, a letter on company letterhead signed by an officer of the business must accompany the transfer form.
- The Club Seat Lease Terms must be indicated on the transfer form.

Part II To be completed by the new Club Seat holder

Part III To be completed along with the appropriate transfer fee

- The transfer fee must be properly computed and submitted with the completed transfer form.
